# **Whole-Life Candidates in 2020**

We have sent endorsement invitations to candidates in 27 of Michigan's 83 counties. (We were unable to reach those from counties that do not publish candidates' email addresses.)

In addition to supporting policies and initiatives that are traditionally associated with the pro-life movement, the candidates endorsed by MDFL also support pro-life policies that are often opposed by Republican politicians, such as:

- health, economic, and social policies that reduce the number of women who feel that abortion is their only viable option, and
- policies that respect the health, lives, and human dignity of workers, people with low incomes, immigrants, minority groups, and everyone else.

# What about other Democratic candidates?

In addition to the whole-life Democrats who have completed our survey, we have also received responses from several pro-choice candidates. (The survey is designed for them too!)

Here is how their numeric scores compare with the scores of candidates who have been endorsed. (The figures represent the range from lowest to highest score.)

The endorsed candidates also provided pro-life responses to several key items on our questionnaire.

Although the pro-choice respondents clearly fall short of our endorsement criteria, they are in agreement with us on several important things. In addition to promoting human life and dignity after birth and economic policies that reduce abortion, they generally agree with us on such things as informed consent, pre-abortion counseling, promoting adoption as an alternative to abortion, and having the legality of abortion determined through a citizen referendum.

# Why does MDFL need to endorse candidates if endorsements have already been made by *Michigan Right to Life*?

From our perspective, the endorsement process of *Michigan Right to Life* falls short in two major respects. First, it does not encompass pro-life policies on which Republicans tend to do poorly, such as policies that protect human life and dignity after birth and economic policies that save lives by reducing the number of people who feel that abortion is their only viable option. Second, it fails to identify many pro-life candidates—particularly Democrats—even if they meet all of their criteria for being 'pro-life.'

Many people assume that any candidates who are not endorsed must be less supportive of an organization's positions, but that is not always the case. Like many other organizations, *Michigan Right to Life* considers several other factors in making its endorsements. The most important factor that prevents them from identifying pro-life Democrats is that they do not endorse other candidates when a previously-endorsed incumbent is running for re-election. The challenger will not be endorsed even if the incumbent has been ineffective and the challenger has better pro-life credentials. This may be good politics—incumbents tend to win, and they are not well-disposed toward organizations that have endorsed their opponents—but it makes the organization's endorsements much less useful for purposes of identifying candidates who are pro-life. This practice also has a disproportionate effect on Democrats: most pro-life Democratic candidates come from pro-life districts, and most pro-life districts have Republican incumbents who have already been endorsed.

(To their credit, they employ this practice without regard to the incumbent's political party. Candidates who challenge previously endorsed pro-life incumbents are never endorsed, regardless of whether the incumbent is a Democrat or a Republican.)

Another factor that can prevent endorsement of pro-life Democrats is the practice of not making endorsements in certain heavily Democratic areas. If they endorsed candidates in Detroit, for example, they would end up endorsing a lot of Republicans with no reasonable chance of winning. That would make the organization's endorsement look less influential and keep them from saying things like "RLM-PAC endorsed candidates had a total win percentage of 93.05%."

Again, this policy is applied to both political parties. Just as they fail to endorse pro-life Republicans with little chance of winning an election in cities like Detroit, they also fail to endorse viable candidates in the Democratic primary who could make a real difference in promoting the cause of life.
